3. Warranty

3.1 Our machine is covered by our standard conditions valid for **24 months** starting from the date of installation finished and delivered to owner or the date after 6 months of shipping date (whichever comes first), specially our steel structure of equipment valid for **36** months starting from the date of lading on ship.

3.2 During the warranty period we will replace any part of the crane that has become defective as a result of a raw material or workmanship-related fault or defect on the basis of a written warranty claim. Company may use his discretion as to whether to provide a new or properly repaired part, or to repair the faulty part.

3.3 The guarantee will not cover the freight and passage charges, nor the cost of board and lodging for this guarantee does not apply to wear and tear parts not to such parts as cable, ropes, belts, etc. where these have not been guaranteed by their manufacturers (although any construction error is covered by the guarantee).

3.4 During warrantee period we grant to Buyer, free of charges, **one** visit of **two** our technicians in site, for crane inspection and checking. Visit will be agreed in accordance with buyer necessities.

4. Spreader or grab

The spreader for container and grab for cargo owns a warranty period of **12** months starting from the date of production in its factory or in accordance with its supplier's warranty standard (whichever come later)..

5. Motor or Engine

It is with a warranty period of **12** month starting from the date of production in supplier's factory, or in accordance with its supplier's warranty standard (whichever come later).

6. Other purchased parts

Such as gearbox, motor, electronics, lubrication machine and any other purchased part that are covered by their suppliers, the warranty shall be **12** months starting from the date of production in factory, or in accordance with its supplier's warranty standard.(whichever come later)
